- enter the transferee's investor number and investor name in Section 3, as they appear on their latest periodic statement or transaction statement
- both you and the transferee need to sign this form as per the 'Signing instructions' in Section 5.

2. Instructions if you are transferring units to a new investor.

If you are transferring units to a new investor, you need to complete the following:

- enter your investor number and investor name as they appear on your latest periodic or transaction statement
- sign this form as per the 'Signing instructions' in Section 5.

The transferee needs to:

- enter their name in Section 4 and sign the form as per the 'Signing instructions' in Section 5
- complete the relevant fund's Application Form
- complete the relevant Identification Form available at www.tyndall.com.au or on request from Tyndall Investor Services
- arrange for copies of their identification documents to be certified.
